Say Yes to the Covid-19 Vaccine

COVID-19 Vaccination Update

In the last two weeks, we have vaccinated approximately 5,200 eligible frontline employees and healthcare personnel, including members of our medical staff. We continue to focus on offering the vaccine to our employees and caregivers, including medical staff, who wish to receive it, prioritizing those with the most risk for exposure to COVID-19. This week, we expanded our vaccination program, adding two vaccination locations in Palm Beach County- at Boca Raton Regional Hospital and Bethesda Hospital East. We are extremely pleased at our team's response to the vaccines and continue to strongly encourage everyone who is eligible to take the vaccine.

Employees and frontline healthcare personnel who are in groups 1B and 1C (see details below) are now eligible to receive the vaccine. This includes all employees who are 65 and older, both clinical and non-clinical, working in any capacity. If you are in this category, or if you are in 1A and have not yet received your vaccine, please follow the process outlined below in order to coordinate your vaccine appointment.

As the information about COVID-19 vaccine distribution is evolving rapidly, we continue to set priorities and strategies aligned with our mission in healthcare and consistent with the Governor's recent executive order, which prioritizes the following risk groups:

- Health care personnel with direct patient contact
- All persons 65 years of age and older
- Patients deemed to be extremely vulnerable to COVID-19 ([click here for details](#))

To date, we have had limited doses of vaccine and have focused on the vaccination of our frontline personnel. Now, with the expectation of more vaccine doses arriving, we are able to begin to expand vaccinations. Our priority remains the continued vaccination of our front-line workers. Simultaneously, we are making plans to offer the vaccine to seniors who are age 65 and older and to other vulnerable patient populations. Additional details around vaccinations for non-employees will be communicated soon.

Thank you for your continued support and flexibility during this rapidly evolving situation.

Vaccination Process

The vaccine is being administered by appointment only. Vaccination of personnel in the same unit/area is being staggered throughout Phase 1 (see priority phases below). **At this time, personnel listed under phases 1A, 1B and 1C are eligible to receive the vaccine.**

If you are interested in receiving the vaccine and meet the phase 1A, 1B or 1C priority group criteria, please notify your leader, who will compile a list of eligible employees interested in receiving the vaccine. Leaders will work with their vaccine Entity Champions who will submit these lists to Occupational Health. Occupational Health will schedule appointments based on the information specified by leadership and will notify each employee by email of their appointment date, time and location.

Once scheduled for your appointment, please make every effort to keep this appointment as the vaccine distribution is carefully planned. It is extremely important to arrive at your designated time on the day of your appointment, as the vaccine needs to be used within a certain window. If you are not able to attend your designated vaccine appointment, please cancel and reschedule your appointment from the email confirmation you received.

You are required to wear a mask for the appointment and **bring your Baptist Health ID, a Florida driver's license or ID, and your current Virgin Pulse clearance** (Virgin Pulse Clearance applies for employees only).

The anticipated duration of the vaccination visit is 45 minutes.

Both the Pfizer vaccine and the Moderna vaccine require two doses of the vaccine. The doses of the Pfizer vaccine must be administered 21 days apart, and the Moderna vaccine is administered 28 days apart. During your first appointment, you will schedule your next appointment to receive your second dose.

Locations

In Miami-Dade County, vaccinations are taking place at the Hilton Miami Dadeland Hotel on the campus of Baptist Hospital.

In Palm Beach County, vaccinations are taking place at Bethesda Hospital East and at Boca Raton Regional Hospital.

Employees and members of the medical staff who are eligible to receive the vaccine based on their phase/priority group can receive vaccine at any location, regardless of their work location.

Prioritization

All employees and direct patient care personnel, including medical staff, who wish to receive the vaccine will be eligible to receive the vaccine according to their priority group unless they have a contraindication. At Baptist Health, we are prioritizing our phased vaccine distribution to our healthcare personnel per guidelines established by the Governor's order based on [CDC recommendations](#) as follows.

Phase 1A:

During the first phase of vaccination, the initial limited doses will be given to healthcare personnel who are most likely to come into contact with patients who have or may have COVID-19.

- Patient care and support personnel who work in the following areas (including temporary contracted employees, such as traveler nurses):
 - COVID-19 units
 - Respiratory Therapy

- Patient care units (for example: ICU, Med/Surg, Labor & Delivery)
- Emergency Departments
- Urgent Care Centers and Urgent Care Express locations
- Practices who see patients with acute flu-like illness that might be COVID-19 (not limited to BHMG)
- Personnel who support patient care areas with at-risk/immunocompromised patient populations
 - Miami Cancer Institute and Lynn Cancer Institute
- Personnel who support areas noted above including but not limited to:
 - Residents and fellow trainees, Laboratory personnel, pharmacy, patient transporters, radiology, physical therapy, occupational therapy, speech therapy, social work, case managers, rehab and environmental services
 - Emergency CODE response team members

Phase 1B:

- Employees and medical staff members who are included in Phase 1A but were unable to receive a vaccine during Phase 1A
- All Baptist Health employees or healthcare providers, including medical staff, who work in a setting where patients are seen
- Any employees and medical staff who are over 75 years old and above

Phase 1C:

- Any employees and medical staff who are 65-74 years old

Contraindications

You should not receive the COVID-19 vaccine if the following applies to you:

1. You have a history of severe allergic reaction to vaccines (such as anaphylactic reaction requiring use of adrenaline autoinjector)
2. You have had a vaccine in the last 14 days, including the flu vaccine
3. You have been treated for COVID-19 with plasma therapy or monoclonal antibodies within the last 90 days.

If you are immunocompromised, you may accept the vaccine, but it may be less effective than in healthy individuals. Please consult with your physician.

[Pregnant women](#) and those who are breastfeeding may take the vaccine, but they should consult with their physician prior to doing so.

If you have been positive for COVID-19 and/or are not currently in the isolation period, you may wait 90 days after infection to take the COVID-19 vaccine. The CDC suggests reinfection is uncommon in the 90 days after initial infection and therefore, individuals with documented acute infection in the preceding 90 days may defer vaccination until the end of this period, if desired.

Side Effects & Other Considerations

Side effects from the vaccine may include fatigue, fever, body aches, and gastrointestinal discomfort. These symptoms are not guaranteed, and are most common after the second vaccine. It is acceptable to take acetaminophen and/or ibuprofen to treat those symptoms if they appear, but IT IS NOT RECOMMENDED to take these medications before vaccination to prevent symptoms before they start, as it is unknown if they may interfere with your body's antibody response and vaccine effectiveness.

The VAERS, or Vaccine Adverse Event Reporting System is a national program managed by the CDC and FDA to monitor the safety of all vaccines licensed in the United States. The CDC has also launched V-Safe, a smartphone-based tool that allows you to report any side effects after getting the COVID-19 vaccine and also sends reminders about your second vaccine dose. About the COVID-19 Vaccine

Studies have shown the Pfizer and Moderna vaccines to be 95 and 94.1 percent effective, respectively. Extensive clinical trials were conducted to evaluate these COVID-19 vaccines. No serious safety concerns have been reported.

After vaccination, the CDC recommends that everyone continues using all the tools available to us to help stop this pandemic, like covering your mouth and nose with a mask, washing hands often and staying at least 6 feet away from others.
